Contingency day, June 2020 examination series

"How might the contingency day be used in the June 2020 examination series?"

In the highly unlikely event that there is national disruption to a day of examinations in summer 2020, and as a last resort, the affected examinations will be rescheduled. Although every effort would be taken to keep the impact to a minimum, it is possible that there could be more than one timetable date affected following the disruption, up to and including the contingency day on **24 June 2020**.

Schools will be alerted if it is agreed to reschedule the examinations and the affected candidates will be expected to make themselves available in such circumstances. Where candidates choose not to be available for the rescheduled examination(s) for reasons other than those traditionally covered by special consideration, they will not be eligible for enhanced grading arrangements.

This is crucial to take into account when making your personal family and posting arrangements in the summer.

Release of results to candidates

- GCE, BTEC L3, EXT. PROJECT: Results will be available for collection from the Exams Office on Thursday, 13 August 2020 (from 10:00 am 13:30 pm).
- GCSE: Results will be available for collection from the Exams Office on Thursday, 20 August 2020 (from 10:00 am 13:30 pm).



Transport Arrangements for Entitled Students

There are four possibilities on any one day:

- 1. If your child only has a morning exam then they will come into school as normal and leave at the end of the day as they normally would with the rest of the school pupils.
- 2. If your child only has an afternoon exam* then we will make arrangements for them to be picked up and brought into school for about 12:30. They will then be taken back by the exams bus at the end of their exam.
- 3. If they have both a morning and an afternoon exam then they will come into school as normal for a 08:00 start and will return on the exams bus following their PM exam. This is a very long day for the students and they need sufficient water and food to sustain them. There will be an air conditioned space for them to rest in between 14:00 and the start of the PM exam. They are also allowed to sign out at 2pm and walk to the shops to buy lunch.
- 4. If your child has no exams on a given day then they will be given the option to attend revision lessons in school or to have a 'study at home' day with parental permission. Please see the attached form.

DfES stipulates that no study leave should be granted to any student

GCSE students must attend school full time until **12 June 2020** when the majority of GCSE exams have been completed following one of the four arrangements above. A study/revision timetable for the remaining exams after this date will be issued to all students and parents nearer the time.

Transport will continue to be provided into school for either morning (as normal) or afternoon exams as outlined below.

PLEASE NOTE: If any student misses the transport provided for any reason, it is the responsibility of the parent to arrange transport for their child to school.
